AGREEMENT OF SALE OF A DOGS VICTORIA REGISTERED DOG

on the clear understanding that: *(delete and initial clauses not applicable)*

1. DECLARATION BY THE SELLER *(Delete one of the clauses A or B. Both parties initial the remaining clause).*

- A The dog is registered on the ANKC Main Register and as such is able to be bred and/or exhibited in events conducted under the auspices of Dogs Victoria or other ANKC member body or exported within the confines and restraints of the Rules and Regulations, Code of Ethics and Codes of Practice of Dogs Victoria, or of another ANKC member body.
- B The dog is registered on the ANKC Limited Register and while it is on the Limited Register, under ANKC regulations, it cannot be used for breeding purposes, be exhibited in conformation events or be exported. With the specific written agreement of the breeder and the current registered owner the dog can be transferred to the Main Register.

- 1.1 The seller warrants the dog has been inspected by a veterinary surgeon; a copy of the veterinary inspection certificate and a certificate stating that the dog has been temporarily/permanently vaccinated or titre tested under the Dogs Victoria Health Management Plan is attached.
- 1.2 The seller confirms that the Dogs Victoria Code of Practice for Hereditary Diseases has been complied with by the seller and that all reasonable steps have been taken to ensure the dog is healthy as required by Dogs Victoria Code of Practice.
- 1.3 The seller confirms that the requirements of Dogs Victoria Code of Practice for the keeping, welfare, breeding and disposal of dogs by members of Dogs Victoria has been observed and complied with in the sale or other disposal of the said dog, in particular regulation 20.1.25

2. DECLARATION BY THE PURCHASER (Referred to as the Purchaser)

- 2.1 The purchaser agrees that if the dog is registered on the Limited Register it will not be bred from or exported. Should it be exported Dogs Victoria will not issue export documentation for the said dog.
- 2.2 The purchaser hereby agrees that within 72 hours of the collection of the dog the purchaser will take the dog to a veterinary surgeon to confirm that the dog is in good health. In the event the purchaser does not take the dog within 72 hours to a veterinary surgeon as agreed herein then the purchaser acknowledges and agrees that it is in good health at the time of purchase.

CONSENT TO CANCELLATION/VARIATION

Terms/Conditions of Cancellation/Variation:

- 1. I/We hereby cancel the said Agreement
2. I/We hereby agree to the variation of the said Agreement by:
2.1 Deletion of the following Clauses or sub-Clauses; and/or
2.2 The insertion of the following Clause and/or sub-Clause/s as follows below-

1. The buyer nor any member of their household participates or has been cautioned for or convicted of any breach of animal welfare law such as neglect, dog fights, cruelty, or abandonment.
2. The puppy or adult dog cannot be on-sold or gifted to anyone. In the even that you are no longer able or willing to provide a home or otherwise meet the Puppy/Adult's future health and welfare needs you are to contact ANATARKO for support, recommendations, including return of the Puppy*.
3. The buyer agrees to take the puppy to the Vet soon after purchase, for a general health check and advice on vaccinations, worming and de-sexing at a time of Veterinarian's recommendation.
4. Ensure Health and Welfare Needs of your Puppy/Adult dog, that they remain healthy, must be loved and cared for they are properly housed, have on-going protection from heat and cold, access to fresh water, correct diet-feeding not fat or skinny, trained, socialised, and exercised, safe from medications and toxic foods, wearing correct harness, no off the lead in public spaces, safe and secured when travelling.
5. You cannot farm/stud or breed your dog at all. If you ignore this agreement, *you will be liable for action at your expense; fees and removal of your dog and puppies pending assessment. Any puppies produced will be the property of ANATARKO and you will pay the full fee of what we sell puppies for and the consequence of breeding without terms to do so.
6. If we become aware that you are abusing your dog, make no mistake the dog will be removed, and appropriate actions will be taken against you or the person/s. By signing this you understand that we are serious about Animal welfare, and that you agree to love, care, and never abuse your dog.

I/We, the purchaser, acknowledge that the breeder has explained to me/us that the puppy/dog being purchased has been registered on the Limited Register of Dogs Victoria in accordance with Regulation 4.1.12, which is reproduced below.

I/We, the purchaser, understand that a puppy/dog registered on the Limited Register cannot be used for breeding and cannot be exhibited in conformation shows (dogs shows), but can participate in other activities including performance disciplines such as agility, obedience, dances with dogs, tracking, endurance, retrieving etc.

By continuing to complete the purchase of the puppy/dog I/We, the purchaser, undertake that the puppy/dog will not be used for breeding.

4.1.12 Limited Register

4.1.12.1 A dog shall be eligible for registration on the Limited Register if that dog is nominated for registration on the duly completed application for registration form, as determined by Management Committee from time to time and accompanied by the appropriate fee and is included with the initial litter registration application and is:

- 4.1.12.1.1 Ineligible for exhibition at a Conformation Show; or
- 4.1.12.1.2 For any reason not to be used for breeding purposes; or
- 4.1.12.1.3 Not entire or has been neutered; or
- 4.1.12.1.4 Not registered in the main register.
- 4.1.12.1.5 Not registered in the associate register.
- 4.1.12.1.6 Ineligible for the issue of export documents, except to another Limited Register.
